Part B. CV Summary

Elisabet Garrido received her PhD in Management from the University of Zaragoza. She has been Visiting Research at the Strathclyde University of Glasgow (three months in 2011) and at Ca'Foscari University of Venice (four months in 2015). She is currently Senior Lecturer in Management at the University of Zaragoza, where she teaches Strategic Management. Her research primarily focuses on the analysis of strategic decisions adopted by companies and their consequences on firms' economic and environmental performance in an international context. Her results have been published in some of the leading journals of the field, such as Strategic Management Journal, Journal of Management, Global Strategy Journal, Journal of World Business, and Business Strategy and the Environment, and have been presented in the main national and international conferences. In the field of entrepreneurship, since 2008 she has participated in the GEM project of the Region of Aragón and since 2019 also in the GUESSS project. She has participated in five projects of the National Plan of R&D and has been the principal researcher of two regional projects. She has received several distinctions as a researcher, such as the Extraordinary Ph.D Award of the University of Zaragoza (2014), and the Best ACEDE Conference Paper (2018).
