Pilar Bernal received her PhD in Management from the University of Zaragoza, after a four-year contract as pre-doctoral researcher. She has been visiting researcher at Maastricht University during three months in 2016. She is currently Assistant Professor in Management at the University of Zaragoza, where she teaches Strategic Management and Business Policy. Her research primarily focuses on the analysis of the innovation strategies developed by firms and their consequences on innovation performance. More specifically, she studies how contingency factors affect the development of innovation strategies and how persistence in innovation and, more specifically, in collaboration, affects performance. Her results have been published in some of the leading journals of the field, such as Technovation and Industry and Innovation, and have been presented in the main national and international conferences. In the field of entrepreneurship, a recently published paper in Business Strategy and the Environment focuses on analyzing the environmental orientation of companies and their determinants. She has participated in three projects of the National Plan of R&D.
