Silvia Donis graduated in Business Administration and Management with a specialisation in Business Law from the University of La Rioja (2015-2019), with an average mark of 8.092. The first semester of the third year of this degree, she studied at the Università Cattolica del Sacro Cuore (Milan) as an Erasmus+ student. Afterwards, Silvia Donis took the Master in Business Management at the University of La Rioja (2019-2020), which she obtained with an average mark of 8.865. She received the Garnica-UR Scholarship for the Master's Degree, awarded to students with the best records in the Bachelor's Degree. In this academic year, she received the Extraordinary Prize awarded to the best student in the Master's Degree.

In the academic year 2020/2021, Silvia Donis began her studies in the Doctorate in Business Economics at the University of La Rioja, under the joint supervision of Drs. Jaime Gómez Villascuerna and Idana Salazar Terreros. The line of research she decided on was the one called "Organisational management, innovation and results", since it is the one closest to her interests. Specifically, her research is currently focused on understanding the factors that drive and constrain the production of eco-innovations, as well as their business and economic impact.

During the academic year 2020/2021 she has presented her research in different forums. Thus, she presented a communication at the ACEDE National Congress, in which she also had the opportunity to participate as a commentator. She also participated in the Annual Meeting of the Academy of Management, as a presentator and as a reviewer of three papers. She has also presented her research at the Applied Economics Teaching Conference, the Jr. Faculty TIM Workshop, the Workshop of Young Researchers in Economics and Business and UCLM and ECSB co-branded event: Conducting Research on Eco-innovation and Circular Economy in SMEs.

In addition, since the academic year 2019/2020 and until today, she has maintained an employment relationship with the University of La Rioja, under the figure of Interim Contract Professor and Professor with a contract of Substitution (in the Department of Economics and Business; area of Business Organization). Moreover, she has complemented her studies with various training courses, related to teaching and research. This training has allowed her to acquire skills for the completion of her doctoral thesis and for the performance of teaching tasks.
